Sir / Madam,

In view of denial letter issued by the National Commission for Homoeopathy, New Delhi /Central Government vide above cited letter dated 23/11/2022, your College has taken legal recourse against the impugned letter dated 23/11/2022 Of National Commission for Homoeopathy, New Delhi and challenged it in the Hon'ble Delhi High Court, New Delhi vide Writ Petition (C) 127/2023, W. P. (C) 137/2023 & CM APPL. 5481/2023 (Interim Relief). However, the Hon'ble High Court, New Delhi vide Interim Order dated 06/01/2023 has directed the respondents to allow the petitioner to participate in the ongoing as well as in the upcoming counselling for the academic session 2022-2023. The petitioner is also directed to publish a notice on its portal informing the general public and the prospective students that petitioner's participation in the counselling is subject to the outcome of its pending second appeal as well as the present writ petition.

Accordingly, as per Hon'ble Delhi High Court, New Delhi Interim Order dt. 06/01/2023 is considered by the University and the Continuation of Affiliation to the (Under Graduate) B.H.M.S. course of your College is granted as per the provision u/s 68 and 65 (4) of MUHS Act 1998, for the Academic Year 2022-23, subject to following conditions:

- Subject to final outcome in Writ Petition (C) 127/2023, W. P. (C) 137/2023 & CM APPL. 5481/2023.
- The intake capacity shall be 60.
- Grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/ National Commission for Homoeopathy/State Government (as applicable).
- Fulfillment of following deficiencies shall be strictly complied within Ninety Days without fail.

- The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
- In case students are admitted in your college, it shall be brought to their notice that their admission is subject to final outcome in W.P.(C) 127/2023, W. P. (C) 137/2023 & CM APPL. 5481/2023 (Interim Relief) and inform students that their admissions are subject to Court Order dt. 06/01/2023. Also, take undertaking from the students as prescribed by Academic Department Circular No. 20/2021 dtd. 08/03/2021 and letter dtd. 12/02/2021 of Govt. of India, Ministry of AYUSH.
- Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

**Important Note:**

- The Continuation / Extension of Affiliation is issued for the Academic Year 2022-2023 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1<sup>st</sup> year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.


