Sir / Madam,

1. In view of denial order issued by the Ministry of AYUSH, New Delhi /Central Government vide above cited letter dated 12/02/2021, your College has approached Hon'ble Mumbai High Court (Aurangabad Bench) for relief.

In light of the Hon'ble High Court Order referred at serial no. 3 above stating that impugned order is modified to the extent that the respondent shall permit the petitioner to admit 30 students for the 1<sup>st</sup> year Homoeopathic Course for the Academic Year 2020-2021 alongwith Interim Order dated 15/04/2021 of the Hon'ble High Court, New Delhi referred at serial no. 4 above stating that Interim Orders to continue. The matter of Conditional Affiliation was placed before the Academic Council meeting held on 28/07/2021 & it has resolved to grant the conditional Continuation of Affiliation/Extension of Affiliation to the Homoeopathy (UG) B.H.M.S. course of your college is granted for the Academic Year 2020-21, subject to following conditions:

- (a) Subject to final outcome in W. P. (C) 4411/2021 with CM APPL. 13500/2021 dated 15/04/2021
- (b) The intake capacity shall be 30
- (c) Grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/Central Council of Homoeopathy/State Government (as applicable).
- (d) Fulfillment of following **deficiencies** shall be strictly complied within Ninety Days without fail.

- The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
- Information of all College Teachers shall be updated on the University Academic Online Teachers Database & monthly review shall be taken by College Coordinator so as to ensure that teacher's information is regularly updated.
- In case students are admitted in your college, it shall be brought to their notice that their admission is subject to final outcome in W. P. (C) 4411/2021 with CM APPL. 13500/2021 and inform students that their admissions are subject to Court Order dt. 15/04/2021. Also, take undertaking from the students as prescribed by Academic Department Circular No. 20/2021 dtd. 08/03/2021 and letter dtd. 12/02/2021 of Govt. of India, Ministry of AYUSH.
- Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year & no student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

**Important Note:**

- The Continuation / Extension of Affiliation is issued for the Academic Year 2020-2021 subject to the permission of Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled.
- The admission shall be done only through the Competent Authorities.
