- 1. As per the provision under Section 65 (4) of Maharashtra University of Health Sciences Act, 1998, I am directed to inform you that, your college was granted Continuation / Extension of Affiliation for Academic year 2021-22 for 60 intake capacity as per permission granted by the Central Government vide above cited letter dated 02/12/2021. Consequently, University has received National Commission for Homoeopathy, New Delhi letter dated 11/02/2022 referred above stating that the Commission decided to grant permission for reduced seats from 100 to 90 for A. Y. 2021-22 in Ratnadeep Homoeopathic Medical College, Jamkhed. Accordingly, the corrigendum in Intake capacity in the Under Graduate course as per National Commission for Homoeopathy, New Delhi vide above cited letter dated 11/02/2022 is considered by the University. Hence the Continuation of Affiliation for Academic Year 2021-22 is here by amended as follows, other contents of the letter dated 09/12/2021 (ref. no. 4) remains same.
 - (a) The intake capacity shall be 90
 - (b) As per grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/Central Council and/State Government, (as applicable).
 - (c) Fulfillment of following deficiencies and submission of its compliance report within Three Months from the date of issuance of this letter:

 - **a.** The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (Format attached).
 - **b.** Information of all College Teachers shall be updated on the University Academic Online Teachers Database & monthly review shall be taken by College Coordinator so as to ensure that teacher's information is regularly updated.
 - c. Those UG/PG qualifications that are not yet recognized by the Central Govt. it is mandatory for the college to apply to the Central Council through Central Govt. and ensure that Permitted/Not Recognized qualifications are enlisted in "Recognized Qualifications", failing which Permitted/Not Recognized qualifications or student shall be admitted in such courses.

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

Important Note:

- The Continuation / Extension of Affiliation is issued for the Academic Year 2021-2022 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1st year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- 2) The admission shall be done only through the Competent Authorities.
